Goal of Position	Conduct the campaign to make the recovery and fiscal reform delivering the Just Transition
Main Functions & Responsibilities	<p>Policy development and advocacy</p> <ul style="list-style-type: none"> Develop and implement a campaign on in order to contribute to a resilient and fair recovery by monitoring national recovery and promoting fiscal reforms to enable a just transition; in particular: <ul style="list-style-type: none"> inform the ongoing development of national recovery plans, track and monitor national implementation of recovery plans and funds; exploit the upcoming review of the EU economic governance and fiscal framework in order to promote the transformational potential for fiscal reforms, the drivers of green investments, and the macroeconomics of the Green Deal; promote the campaigns for a more social and sustainable Europe that unites social and environmental sustainability as a central pillar of the transformation by amplifying the voice of environmental and social movements and trade unions; Develop and coordinate joint advocacy tools (briefings, letters, position papers, reports, media products etc.) with members and partners. Organise and host a platform to unite stakeholders in their advocacy around Green Deal consistency of recovery plans. Coordinate advocacy and media outreach with Finance and Subsidies Policy Coordinator, Communications Coordinator and Network Coordinators. <p>Coordination of network positions and strategies</p> <ul style="list-style-type: none"> Develop a CAN Europe position on the review of the EU Fiscal Framework. Produce regular updates and materials for the network and the website. Cooperate with the Finance and Subsidies Policy Coordinator in the regular exchange with and capacity building of CAN Europe members and partners.
